

## Residential Landlord Hazardous Waste Service

### Landlord Service Description

The Alameda County Household Hazardous Waste (HHW) Residential Landlord Hazardous Waste Service (Landlord Service) can save money for a qualifying owner or landlord. The Landlord Service accepts waste generated during maintenance of a rental property or left by a tenant at a residential property and provides an alternative to using a hazardous waste management contractor for hazardous waste transport and disposal.

Under California hazardous waste regulations **a residential landlord or building owner must manage hazardous waste as a business**. However, a residential landlord having 4 or fewer units on the same parcel and whose legal residence is in one of the units may use the Household Hazardous Waste facilities as a resident.

**The Landlord Service accepts waste from qualifying landlords of residential property free of charge.** No fee is charged to a landlord for accepting waste generated from maintaining a residential property or for waste left by a tenant if the waste was generated in the course of living in or maintaining the place of residence. Waste from a business activity by a tenant cannot be disposed of through the Landlord Service. To use the Landlord Service you need to:

- Qualify as a Very Small Quantity Generator, and obtain an EPA ID number for the rental site
- Complete and send an application, get account an number and each have each waste type approved.
- Make an appointment for each waste delivery by calling the HHW office: 800-606-6606
- Deliver waste on days and times separate from when a resident may deliver

A landlord that generates hazardous waste must comply with local and State requirements for safety and environmental protection. ### Who Can Use the Landlord Service?

The Service is available to a rental housing owner or landlord or condo owner association that generates waste in Alameda County. To use the Landlord Service each residential property must qualify as a Very Small Quantity Generator (VSQG) of hazardous waste, which means: the site may generate no more than 220 lbs. (about 27 gallons) of hazardous waste per month, and less than 2.2 lb. of Extremely Hazardous Waste per month (Extremely Hazardous Wastes are unlikely to be found in a residential setting) and the site may accumulate no more than 2200 lbs. of hazardous waste at any time.

A management contractor or hauler **cannot** apply to use the Services or deliver waste on behalf of the property owner or landlord.

### How to Start

**Any business that has hazardous waste needs a California Environmental Protection Agency generator ID number.**

**To get an EPA ID Number for a rental property or to re-activate an inactive number** visit the California EPA website:

If you do not use a computer, you may get a temporary EPA ID Number by calling: 800-618-6942

AN EPA ID number is not required if your property will dispose of ONLY latex paint and/or Universal Waste

### Complete & Submit Application Forms, Get Approved

Complete the **Information Form**, **Inventory Form** and **Certification Form** attached below for each rental property. The Certification Form is a legal document attesting that the site meets the criteria of a Very Small Quantity Generator.

The HHW program will review application forms, will resolve any questions, and will send a letter with confirmation and account number to applicants eligible to participate in the program.

### Call to Make an Appointment

After you receive a confirmation of approval to use the Service and an account number **Call 800-606-6606 to schedule an appointment.** HHW facilities accept hazardous waste from a Landlord or businesses on different days than when residents or tenants can drop off waste from their household – a business cannot deliver waste on days a HHW facility is open for residents. **No appointments are made on-line, no delivery is accepted without an appointment.**

### What Can I Deliver?

A list of typical waste types accepted is below, including many common consumer and building maintenance products. List the items you need to dispose of on the **Inventory Form**. Each waste will be reviewed and approved before acceptance. Submit a new Inventory Form for approval each time new waste type(s) need disposal. Products that are uncommon for a residence may be accepted after case-by-case review. Call the HHW office with questions. See below for limits on amounts and requirements for containers and transportation.

### Waste That is NOT Accepted

The Landlord Service does not accept the following waste types:

- **Electronic Waste, appliances, furniture, trash or solid waste**
- **Compressed gas cylinders - except for propane for camping or BBQ**
- **Fire extinguishers**
- **Medications, drugs, sharps or other Medical Waste, sewerage**
- **Explosive, radioactive or unstable materials, or waste with multiple or extreme hazards**
- **Construction materials: including Treated Wood Waste or asbestos-containing waste**
- **Contaminated soil or debris** from site clean-up, demolition or lead paint removal
- **Unidentified waste:** the HHW program will not accept unknown materials, including wastes or chemicals lacking labels or other identification.

### Limits on Waste Amounts and Container Sizes

**The maximum amount you may deliver per delivery and per month: 220 pounds of hazardous waste and 2.2 pounds of extremely hazardous waste** (see definition in legal citations below)

Monthly weight limits do not apply to latex paint, lamps, household type batteries or aerosol cans. If delivering latex paint or batteries, deliver no more than 1000 pounds total per trip.

**No container or item may be over 5 gallons size or weigh over 50 pounds.**

### Containers and Safe Transport

- **A business must transport its own waste.** An employee of the waste generator must deliver waste. A contractor or for-hire hauler **cannot** deliver for another business.
- **Transport waste in containers that:** prevent leaks or breakage, are securely closed and in good condition with no hazardous residue on the outside of the container.
- **Each waste container must be:** impervious to, and not damaged by, the waste contents. Pack waste with liquid or volatile ingredients in a hermetically sealed container. A dry solid waste with non-volatile ingredients may be packed in thick, sealed plastic bag up to 5 gallons in size. Pack sharp-edged or breakable waste in a rigid puncture-resistant container.
- **Battery packaging:** insulate terminals of all lithium, lithium-ion and lead/acid batteries, and any other battery over 9 volts capacity. Pack battery types separate. Pack damaged, defective or recalled lithium-ion batteries up to 300Wh each in a bag in non-combustible container separated by layers of non-combustible sorbent.
- **Do not mix waste types** in the same container, prevent incompatible chemicals from mixing.
- **Mark each container** with the contents, cross out or remove any incorrect label.
- **Pack, load and brace containers in vehicle** to prevent movement, breakage, damage or spill or waste mixing during transport.
- **HHW staff will unload waste.** Remain in the vehicle unless asked to step out. Pack waste to be easily accessible to HHW staff, not in passenger area. The site will keep containers.

### Best Practices for Landlords

Inform tenants of their responsibility to handle their hazardous waste safely. Consider making proper waste disposal part of a lease agreement and an element of the security deposit. Inspect property periodically for hazardous materials and proper waste management.

- Recycling and disposal options for many unneeded items can be found at: <https://resource.stopwaste.org/> Inform tenants of local options: some paint stores, hardware stores and oil changers take back some common items such as paint, batteries, fluorescent lamps, E-waste and used oil. Many pharmacies accept waste medications and home-use sharps waste.
- Landlords may also use some local options for small quantities of business waste subject to the terms and conditions of each store or drop-off location
- Inspect property for safe storage of hazardous materials or for building materials that require special management: mercury thermostats, landscape or maintenance chemicals, electronics, treated wood, asbestos
- Use qualified contractors for demolition and construction and to manage materials needing special handling that a landlord cannot dispose of through the HHW Services

### Waste Types Accepted

<b>HAZARDOUS WASTES – limit 220 pounds per delivery/month</b>
<b>PaintCare Eligible Paint:</b> Oil & Non-Latex: stain, varnish, deck coating, floor paint (including elastomeric), primer, sealer, undercoat, shellac, lacquer, varnish, single component urethane & epoxy, waterproofing, field & lawn paints, concrete/masonry/wood and repellents (no tar or bitumen-based), metal coatings, rust preventative
<b>Non-PaintCare Paint and Paint Related Materials:</b> (Oil and Latex) OEM & vehicle paint, ink, colorant & pigments, roofing tar, adhesive, joint compound, glaze and other petroleum-based products, paint sludge, containers under 1 gallon of oils, solvents and flammable liquids
<b>Thinner, Solvents, Flammable liquids, Detergent liquids, oils that are hydraulic, contaminated or mixed (non-PCB):</b> Containers one gallon and larger, 100% free flowing liquid
<b>Chemicals, other than Toxic/Poisons:</b> Acids, Bases, Oxidizers, Salts, Photo chemicals, cleaning products, pool or spa chemicals, bleach, laboratory chemicals, small containers & non-pourable flammable liquids & other
<b>Poison and Toxic materials:</b> Liquids or solids; Pesticides, Herbicides, Fungicides, other Toxics
<b>Lead Paint Chips, Contaminated Soil/Sorbents:</b> suitable for Hazardous Waste landfill
<b>Lamp Ballasts:</b> Magnetic transformer type under 15 lbs. (PCB and non-PCB)
<b>Antifreeze –</b> containers one quart or larger
<b>Photo Chemical liquids</b> (developers, fixers, stop baths) - containers 1 gallon or larger
<b>Motor Oil or Lubricating Oil –</b> containers one quart or larger
<b>Oil Filters</b>
<b>Flammable Solids, Fuel filters -</b> Solids containing gasoline or other volatile organics, other contaminated soil, sorbents or, media requiring incineration
<b>Mercury</b> in sealed puncture-proof container: <b>Broken lamps, Mercury Containing Articles, mercury batteries, spill cleanup debris</b>
<b>Propane cannisters:</b> small camping type cannisters - up to 1 pound capacity. Including MAAP, butane and “Gaz” cannisters
<b>Propane cylinders:</b> gas grill type, no vehicle tanks or resident types – up to 20 lb. capacity. Estimated weight: 20 Lb. ea.
<b>Battery: Lead-Acid with liquid electrolyte</b> from motor vehicle, boat, engine starter: all terminals insulated. Estimated weight: 30 Lb. ea.
<b>UNIVERSAL WASTES – not subject to 220 pound per delivery/month limit</b>
<b>Aerosol Cans</b> up to 16.4 oz.
<b>Batteries: Alkaline, Carbon zinc, Nickel Cadmium and Nickel Metal Hydride -</b> terminals insulated if over 9 volts, no liquid electrolyte
<b>Batteries: Lithium, Lithium ion -</b> all terminals insulated, max.300 Wh, NO motive power, BESS batteries
<b>Batteries: Sealed Lead Acid -</b> terminals insulated, no liquid electrolyte, max. 40AH, 11 pounds
<b>Damaged, defective, recalled (DDR) Lithium-on Batteries:</b> punctured, crushed, swollen lithium-ion packs $\leq 300$ Wh Each battery bagged, terminals insulated, layered in non-combustible absorbent, in non-combustible container
<b>Fluorescent and LED lamps, intact: Straight tube lamps, <math>\geq 2</math> ft.</b>
<b>Fluorescent and LED Lamps, intact: Compact Fluorescent &amp; LED lamps, D tubes, U tubes, PL inserts, small tubes, &amp; misc. fluorescent lamps</b>
<b>HID Lamps, intact - Mercury Vapor, Sodium Vapor, headlight, arc, UV, Metal Halide</b>
<b>LATEX PAINT – not subject to 220 pound per delivery/month limit</b>
<b>Latex Paint – water-based architectural paint</b>

To describe wastes typical of household or building maintenance you may use general terms such as listed below. For laboratory, industrial or manufacturing wastes include a detailed description with chemical names, a Safety Data Sheet or laboratory analytical report.

- Paints:** stain, shellac, thinner, oil base paint, epoxy paint, urethane two part paint, paint colorant, dryer, roofing tar
- Adhesives:** calk, putty, plaster, drywall mud, spackle, mortar, cement, grout, stucco
- Auto products:** diesel, gasoline, ATF, brake fluid, motor oil, oil filter, fuel filter, wax, polish, antifreeze
- Garden products:** fertilizer, soil treatment, herbicide, pesticide, insecticide, spa or pool shock, chlorine tablets
- Misc:** Cleaner, disinfectant, detergent, floor wax, floor stripper, hand sanitizer
