# I. About the Agency

StopWaste is a public agency responsible for reducing waste in Alameda County. We help local governments, businesses, schools and residents with projects and initiatives that:

- · Increase recycling and reduce waste
- Develop and expand markets for recycled materials
- Provide technical and implementation assistance to increase recycling
- Motivate people to make recycling and waste reduction part of their everyday routines.

We are governed by three Boards: the Alameda County Waste Management Authority, the Alameda County Source Reduction and Recycling Board, and the Energy Council.

StopWaste is requesting qualifications from firms to assist in printing and sign production services to support new and on-going agency programs. For more information regarding our organization and programs, visit our website: www.StopWaste.org

Selected firms will be placed in a "prequalified vendors list". Those included in this list are eligible, but not guaranteed, to receive a bid request as services are needed by StopWaste staff. This prequalified vendors list is valid from July 1, 2015 through June 30, 2018.

## II. Description of Services and Qualifications Required

StopWaste develops and maintains a wide range of initiatives to promote the Agency's programs. Due to the volume and variety of the various programs, the Agency needs to maintain an up-to-date list of printing, signage and promotional materials providers who can assist in the execution of the various programs and initiatives. StopWaste is seeking assistance with the following tasks:

## A. Printing

Specific printing jobs range in quantity from 500 – 400,000 pieces. Printing projects may include: brochures, booklets, flyers and inserts.

### Qualifications Required:

- Ability to use 100% recycled stock with the highest possible percentage of post-consumer content, and no less than the minimum recycled content standards established by the U.S. EPA Guidelines
- Ability to use soy based inks

#### General Qualifications:

The Agency encourages printing and signage companies that it contracts with to be certified as Green Businesses by the Bay Area Green Business Program. Find out more information about this program at www.greenbiz.ca.gov

The following insurance policies are required by our agency:

- Comprehensive general liability insurance, including personal injury liability, blanket contractual liability, and broad-form property damage liability coverage.
   The combined single limit for bodily injury and property damage shall be not less than \$2,000,000.
- Automobile bodily injury and property damage liability insurance covering owned, non-owned, rented, and hired cars. The combined single limit for bodily injury and property damage shall be not less than \$1,000,000.
- Statutory workers' compensation and employer's liability insurance as required by state law.

All materials and work samples are to be printed double-sided on 8-1/2" x 11" recycled content paper when applicable.

Please note Faxed responses will **not** be accepted.

Qualifications received after 5:00 p.m. on May 13, 2015 will **not** be accepted.

Depending on the responses to this RFQ, the Agency will select more than one firm or individual to be placed on the prequalified vendors list.
