**SUBJECT:** Resolution regarding meeting via teleconference to promote social distancing,

pursuant to AB 361

#### **SUMMARY**

On September 16, 2021, the Governor signed into law as an urgency measure, AB 361 (Rivas), which allows local legislative bodies to continue to meet by teleconference in order to promote public health and safety, subject to certain conditions, which must be reconsidered every 30 days. At its February 9, 2023, meeting, the Recycling Board will consider a resolution to approve and direct the continued use of teleconferencing for its public meetings to enable social distancing, as long as the findings required by AB 361 are met and other provisions of the Brown Act are followed.

#### **DISCUSSION**

In light of the continued state of emergency declared by the Governor related to COVID-19, state and local officials have imposed or recommended measures to promote social distancing. This direction from state and local health officials is based on the increased safety protection that social distancing provides as one method to reduce the risk of COVID-19 transmission.

The state of emergency and associated direction from state and local health officials to promote social distancing continues to impact the ability for the Recycling Board to meet safely in person. The direction from public health officials that informs the findings in the attached resolution has not changed. Therefore, staff recommends that the Recycling Board approve the attached resolution to direct the continued use of teleconferencing for its public meetings to enable social distancing, as long as the findings required by AB 361 are met and other provisions of the Brown Act are followed. The Recycling Board will need to revisit the need to conduct meetings remotely at least every 30 days following adoption of the attached resolution.

## ALAMEDA COUNTY RECYCLING BOARD RESOLUTION #RB 2023-02

## MOVED: SECONDED:

#### AT THE MEETING HELD FEBRUARY 9, 2023

**WHEREAS,** in response to the COVID-19 pandemic, the Governor adopted a series of Executive Orders allowing the legislative bodies of local governments to meet remotely via teleconference so long as other provisions of the Brown Act were followed; and

**WHEREAS,** on September 16, 2021, the Governor signed into law as an urgency measure, AB 361, which allows for the continued use of remote meetings by local legislative bodies subject to certain conditions, which must be reconsidered every 30 days; and

**WHEREAS,** the Recycling Board has considered the current state of health guidance related to public meetings in Alameda County and finds it necessary to continue with remote meetings to promote public health and safety.

**NOW THEREFORE BE IT RESOLVED,** that the Recycling Board approves and directs the continued use of teleconferencing for its public meetings based on the following findings required by Government Code Section 54953(e), as amended by AB 361:

- The entire State of California remains under a proclaimed state of emergency as declared by the Governor of the State of California related to the COVID-19 pandemic.
- State and local officials have imposed or recommended measures to promote social distancing. For example, on September 23 the Alameda County Health Care Services Agency Director recommended social distancing at all meetings of the Board of Supervisors and its committees. This recommendation is consistent with the Division of Occupational Safety and Health of California's (Cal/OSHA) Emergency Temporary Standards, which require employers to train and instruct employees that the use of social distancing helps combat the spread of COVID-19 (8 Cal. Code Regs. 3205(c)(5)(D).).
- The state of emergency continues to directly impact the ability to meet safely in person.
   For example, given the constraints of the Recycling Board's available meeting spaces, social distancing is difficult without severely limiting space for members of the public to attend.
- The Board anticipates this resolution will appear on its consent calendar for review and ratification or update at each regular Board meeting for as long as the Governor's proclaimed state of emergency related to the COVID-19 pandemic remains in effect and the Board desires to continue remote public meetings.

#### **BE IT FURTHER RESOLVED,** that:

- 1. Recycling Board meetings will continue to be conducted remotely for the next 30 days in compliance with AB 361, to better ensure the health and safety of the public.
- 2. The Recycling Board will reconsider the circumstances of the state of emergency and the need to conduct meetings remotely at least every 30 days following adoption of this resolution.
- 3. If the Board determines the need still exists at each 30-day mark, the determination will be ratified by a vote of the Board documented in the minutes of that meeting.

**SUBJECT:** Request by City of Berkeley to utilize Measure D funds for a contract exceeding five years

#### **SUMMARY**

The Recycling Board has adopted certain Measure D implementation policies and procedures related to the use of recycling fund monies for contracts longer than five years. Per Resolution RB 98-3, the Recycling Board must approve a request for any contract longer than five years. As such, the City of Berkeley is submitting to the Recycling Board a request to utilize Measure D funds to pay for a five-year contract, with the option to extend the contract for another five years (for a total of 10 years) for the hauling, sorting, recycling, and marketing services of construction and demolition debris materials (C&D). Rather than being landfilled, C&D materials are sorted into commodities for reuse, recycled into other products such as compost, mulch, energy production, and other permitted and beneficial uses.

#### **DISCUSSION**

Subsection 64.060 (D) of the Measure D Charter Initiative states:

Contracts using Recycling Fund monies shall be made for periods not more than five (5) years, except that upon a finding of the Recycling Board that a longer period is necessary in order to implement a specific project, the Recycling Board may vote to allow a particular contract to be made for a period of not more than 10 years. No contract using Recycling Fund monies shall provide for an option to renew or any similar provisions that would result in the extension of a contract, on a less than fully competitive basis, for a cumulative period of more than five (5) years or, in the case of a contract which the Recycling Board has authorized to be made for a longer period for purposes of capitalization, more than 10 years.

In 1998, Resolution #98-3 was adopted to develop standard policies and procedures for the receipt and evaluation of applications from member agencies requesting use of Measure D monies for contracts exceeding five years in length. The adopted resolution procedures are as follows:

Every municipal applicant should submit information and data regarding:

- 1. Their other uses of Measure D funds in the previous and current fiscal years, and proposed for the upcoming year, if known, including the percentage of Measure D revenues used to reduce ratepayer rates for recycling collection services.
- 2. The circumstances of award of the contract under consideration.
- 3. The expected benefits or factors necessitating a contract term longer than five years.

Applicants requesting use of Measure D funds for contracts over eight years in length (and fewer than 10) shall also describe their good faith efforts to procure innovative services, where practical.

The City of Berkeley has provided the following documentation that meets the above policy requirements:

#### 1. Uses of Measure D funds for fiscal years 21-22, 22-23 & 23-24

In fiscal year 2021-2022, the city spent \$151,804 supporting a variety of Measure D activities, including outreach and promotion, physical assets in recycling and organics carts, and mitigation fees for construction and demolition (C&D) debris from out of county. For fiscal years 2022-2023 and 2023-2024, the City anticipates using Measure D funds to cover similar programs and upfront costs. If the request to enter a contract longer than five years to continue hauling, sorting, recycling, and marketing services of C&D materials is approved by the Board, the City will spend remaining Measure D funds for those services.

#### 2&3. Circumstances of award and the benefits necessitating a contract term longer than five years:

The City of Berkeley will utilize Measure D funds to pay for a five-year contract with Zanker Recycling, LLC, to provide Construction and Demolition recycling services, which includes an option to extend services for an additional five years. Exercising the option to extend for an additional five years allows the City of Berkeley to continue recycling C&D materials uninterrupted, at a fair market price.

**SUBJECT:** Written Reports of Ex Parte Communications

#### **BACKGROUND**

Section 64.130 (Q)(1)(b) of the Alameda County Charter requires that full written disclosure of ex parte communications be entered in the Recycling Board's official record. At the June 19, 1991 meeting of the Recycling Board, the Board approved the recommendation of Legal Counsel that such reports be placed on the consent calendar as a way of entering them into the Board's official record. The Board at that time also requested that staff develop a standard form for the reporting of such communications. A standard form for the reporting of ex parte communications has since been developed and distributed to Board members.

At the December 9, 1999 meeting of the Recycling Board, the Board adopted the following language:

Ex parte communication report forms should be submitted only for ex parte communications that are made after the matter has been put on the Recycling Board's agenda, giving as much public notice as possible.

Per the previously adopted policy, all such reports received will be placed on the consent calendar of the next regularly scheduled Recycling Board meeting.

**SUBJECT:** Waste Prevention Grants Update and Grantee Presentations

#### **SUMMARY**

The Agency utilizes several approaches to support waste prevention and build upstream infrastructure in Alameda County. One such approach is our long-running waste prevention grants program. StopWaste is offering a total of \$1.1 million in funding for projects that focus on innovative approaches to preventing waste in Alameda County. Periodically we bring selected grantees to present to the board for a deeper understanding of how our funding not only supports the environment via waste prevention but our local communities as well. Presenters will provide the board with an overview of their organization and the communities they serve, how they have utilized grant funds, and the impacts made as a result of the funding support.

#### **DISCUSSION**

Staff will provide an overview of the upcoming grants program, and the board will hear presentations from the following grantees:

Loved Twice provides newborns in need with high-quality, reused baby clothing for the first year of life. Loved Twice provides the missing link between those who have perfectly good infant clothes that no longer serve them and new parents in desperate need. Gently used baby clothes are sorted into complete wardrobes-in-a-box for the first year of life and are distributed through social workers in clinics, shelters, and hospitals such as Alta Bates Summit Medical Center and Highland Hospital in Oakland. StopWaste grant funds have allowed Loved Twice to increase the amount of clothes collected and redistributed to Alameda County mothers and babies in need – 600 wardrobe boxes were distributed in Alameda County in 2022 as a result of our funding.

Berkeley Food Network (BFN) seeks to end hunger and poor nutrition by using innovative, community-centered solutions to build a more sustainable, resilient, and equitable food system. By partnering with farms, retailers, restaurants, and other businesses, BFN recovers over 60 thousand pounds of surplus edible food every month. This food goes to their distribution programs and Hub Meal Program, where it is turned into nutritious, individually packaged and frozen vegetarian meals. Last year, StopWaste funding allowed BFN to expand their Food Recovery Program (FRP) as well as establish new donor relationships to secure kitchen ingredients for use in their Hub Kitchen and with food recovery organizations who have hot meal cooking programs. This allowed BFN to recover and distribute over 353 thousand pounds of surplus edible food, serving the equivalent of 294 thousand nourishing meals.
