Jennifer West provided an overview of the 2024 legislative session and an update on the legislation the Agency is pursuing in 2024 that would make changes to the SB 1383 procurement requirements. Board member Hannon thanked staff for the presentation and asked that staff keep the Board apprised of any legislation that would present unfunded mandates or added costs to cities. Board member Wengraf inquired about SB 1013 and its effect on the Bottle Bill. Mr. Burroughs stated that staff would provide a future update to the Board on the Bottle Bill.

Board members Cavenaugh and Jensen commended Mr. Burroughs on his presentation of SB 54 at the Leage of California Cities Environmental Quality (EQ) Policy Committee meeting. Board member Cavenaugh also noted that the City of Mill Valley presented at the EQ Policy Committee on the Marin County reusable foodware ordinance and suggested that the Board hear a presentation from them in

consideration of a countywide ordinance for Alameda County. Mr. Burroughs announced the monthly topic brief, which highlights California's Right to Repair Act (SB 244). The law goes into effect in July 2024 and requires electronics and appliance manufacturers to supply necessary parts, tools, and documentation for repairs to both independent repair shops and product owners. A link to the topic brief is available here.

Mr. Burroughs announced that the Waste Prevention Grants Cycle is now open. Staff will send an email to the Board. StopWaste is offering \$1.1 million in grant funding for projects in Alameda County that focus on waste prevention, reuse, and recovery of food, goods, and materials as well as development, marketing, and products made with recovered materials. Eligible businesses, nonprofits, and institutions are encouraged to apply by March 14, 2024. For additional information and application visit our website.
